

Mahogany Run's "Rock the Rounds" Sweepstakes

Rules and Regulations

- 1. Eligibility:** "Rock the Rounds Sweepstakes" is open to residents of the US Virgin Islands. Participants must be a member of the Mahogany Club or Annual Pass Card Holder for 2017. All dues (past and present) MUST be paid in full (locker, club storage) and you must be at least 18 years of age at the date of entry. Employees of Mahogany Run Golf Course and Dun Run LLC. (the "Sponsor") are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable local laws and regulations.
- 2. Agreement to Rules:** By participating, you agree to be fully bound by these Rules, and you represent that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Mahogany Run Golf Course as final and binding as it relates to the content.
- 3. Sweepstakes Period:** Entries will be accepted starting on Thursday, June 1st 2017 and ending Sunday, December 31st 2017.
- 4. How to Enter:** For every round of 18 holes played, participant will receive 1 RED ticket. For every 9 holes of golf played, participant will receive 1 WHITE ticket. 2 WHITE tickets will be redeemed for 1 RED ticket. Grand prize winner will be drawn from RED TICKETS. Tickets must be received at the time of purchase. Tickets will not be retroactively distributed. Participant is responsible for writing name and phone number legibly on the ticket. The PURCHASER of the round(s) of golf will receive the tickets unless otherwise agreed upon between purchaser and other party. Mahogany Run reserves the right to add "Bonus" dates whereas the single round of golf will result in multiple entries. It is the sole discretion of the Sponsor to select and announce these dates as they see fit.
- 5. Prizes:** Winner(s) will receive A Mahogany Run Green's Fee Pass for 2018 – a value up to \$3,000. The specifics of the prize shall be solely determined by the Sponsor. No cash or other prize substitution permitted except at Sponsor's discretion. The prize is non-transferable. Acceptance of prize constitutes permission for Mahogany Run Golf Course

to use winner's name, likeness, and entry for advertising purposes.

6. **Odds:** The odds of winning depend on the number of eligible entries received.
7. **Winner selection and notification:** Winner(s) of the Sweepstakes will be selected in a random drawing under the supervision of the Sponsor. Winners will be notified via phone call on January 1st, 2018. Mahogany Run shall have no liability for a winner's failure to receive notices due to incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, prize may be forfeited and an alternate winner selected.
8. **Terms:** Mahogany Run reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. In such case, Mahogany Run may select the recipients from all eligible entries received prior to action taken. Mahogany Run reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or violates these Terms & Conditions.
